Requirements for 2024 Concession Rental August 22, 2024–August 25, 2024

A. Outdoor Commercial Rate:

1. \$30 per foot, 10 foot increments = \$300.00
 2. One (1) 15amp/120 volt receptacle included
 3. Corner premium of \$100.00 applies
 4. Tent rental is additional (see attached tent price sheet)
 5. Additional Electric is: Each additional 15 amp/120 volt is \$50. Direct wire charge is \$60.00. 110/220 volt service is \$50 plus \$4 per amp draw.
 6. Camping Fee: \$100.00, Water provided, No power (see camping form).
 7. Please provide a \$1 million secondary insurance liability policy naming W.C.A.S. for above dates. To be put on fair insurance policy is \$150.00
- Example: 10 foot space = \$300.00 Rent + \$100.00 camping fee = \$400.00 plus any tent rental fee or additional electrical.

B. Food Vendors:

1. \$800.00 minimum for a 20 foot space or less
2. Over 20 foot is \$40.00 per frontage foot (minimum 5ft increments)
3. Tent rental is additional (see attached tent price sheet)
4. One (1) 15 amp/120 volt receptacle included
5. Additional Electric is: Each additional 15 amp/120 volt is \$50. Direct wire charge is \$60.00. 110/220 volt service is \$50 plus \$4 per amp draw.
6. Camping Fee: \$100.00, Water provided, No power (see camping form).
7. Please provide a \$1 million secondary insurance liability policy naming W.C.A.S. for above dates. To be put on fair insurance policy is \$150.00

C. Indoor Vendors:

1. \$40.00 per foot (10 foot increments only - Maximum 20 feet).
2. One (1) 15 amp/120 volt receptacle included
3. Additional Electric is: Each additional 15 amp/120 volt is \$50. Electrical is limited inside.
4. Camping Fee: \$100.00, Water provided, No power (see camping form).
5. Please provide a \$1 million secondary insurance liability policy naming W.C.A.S. for above dates. To be put on fair insurance policy is \$150.00

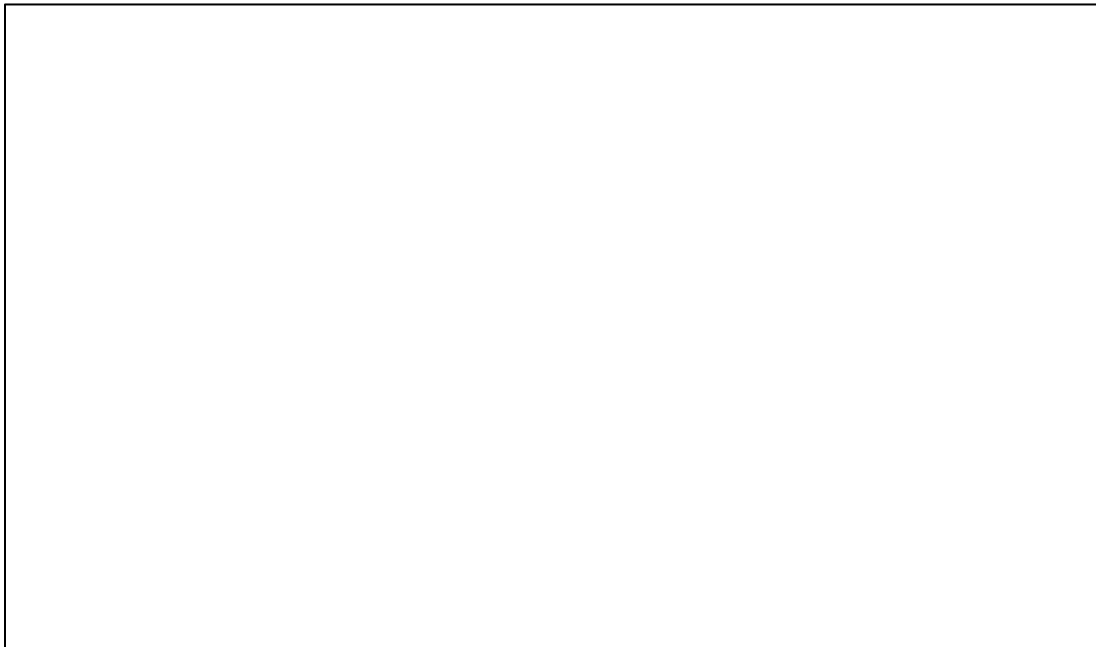
